**ARTICLES OF INCORPORATION
OF
COMMUNITY CHRISTIAN COUNSELING CENTER
OF PALM BEACH COUNTY, INC.,
A FLORIDA NOT FOR PROFIT CORPORATION**

SECRETARY OF STATE
TALLAHASSEE, FLORIDA

The undersigned persons, acting as incorporators of a corporation not for profit under the Florida Not For Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, adopt the following articles of incorporation for the corporation:

Article I

The name of the corporation is Community Christian Counseling Center of Palm Beach County, Inc.

Article II

The principal place of business and mailing address of the corporation shall be 9625 N. Military Trail, Palm Beach Gardens, FL 33410.

Article III

The corporation shall have perpetual duration.

Article IV

The corporation is a not for profit corporation. The corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article V

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article IV hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section

170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article VI

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article VII

The corporation will not have members.

Article VIII

The street address of the initial registered office of the corporation is 8295 N. Military Trail, Suite A, Palm Beach Gardens, FL 33410. The name of its initial registered agent at that address is Roger C. Hurd.

Article IX

The powers of this corporation shall be exercised, its property controlled, and its affairs conducted by a board of directors. The number of directors of the corporation shall be not less than seven (7); provided, however, that number may be changed by a bylaw duly adopted pursuant to the bylaws of this corporation.

The method of election of directors shall be stated in the bylaws of the corporation.
