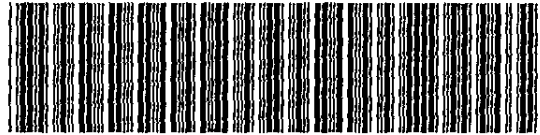

ATTACHMENT TO ARTICLES OF INCORPORATION FOR GREATER FAITH MINISTRIES

Article III Purpose:

The purpose for which the corporation is organized is:

To formulate various ministries with trained members who will be able to address the issues facing the Parramore neighborhood families by bridging them together with existing community resources and also by organizing core programs within the ministries that will directly address the issues facing these families with realistic, practical faith based strategies; thereby lessening neighborhood tensions and improving everyday life.

Greater Faith Ministries of God on the Move Inc. was organized exclusively for charitable purposes under section 501 (c) (3) of the Internal Revenue code.

Upon dissolution of the organization, assets will be distributed for one or more exempt purposes within the meaning of 501 (c) (3) of the Internal Revenue Code, or shall be distributed to the Federal Government, or to a state or local government, for a public purpose.

We agree that no part of the net earnings of the organization will inure to the benefit of, or distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the organization shall not participate in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or (b) by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code.
