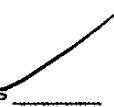

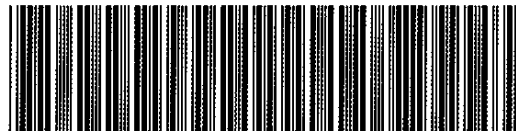

ARTICLE II

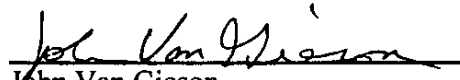
The document number of the Corporation is N06000002065.
