ARTICLES OF INCORPORATION

A FLORIDA NON-PROFIT CORPORATION

The undersigned, for the purpose of forming a Non-Profit Corporation pursuant to Florida Law, Section 617 hereby certifies as follows:

ARTICLE I NAME

The name of this Corporation Not For Profit shall be:

SHEKINAH TRUE DELIVERANCE, INC.

ARTICLE II PURPOSE

This Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue Law).

The specific purpose for which the corporation is formed are for the promotion of the good news of Salvation of Jesus Christ through the use of diverse ministries, including but not limited to, the following:

Television, and Radio Ministries, publication of tracts and other literature; to purchase, sell, and otherwise deal in real and personal property; the building of Churches both within and without the United States; to conduct and promote various missionary and mission related activities in other lands; to conduct training seminars, workshops, and retreats necessary for the promotion of the various Ministries set forth above; and for all other l awful purposes for which a non-profit corporation may be formed under Section 501 (c) (3) of the Internal Revenue Code of 1986.

ARTICLE III DISTRIBUTION

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for the services rendered and to make payments and distributions in furtherance of the purpose set forth in Article ii hereof. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene is (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue Code) or (b) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Revenue Law).

ARTICLE IV EXISTENCE

The corporation shall have perpetual existence.

ARTICLE V QUALIFICATION OF MEMBERS

Membership shall be freely admitted to the Corporation, who are willing to promote the purpose of this corporation. The qualification of members shall be set by the by-laws of the corporation. Men, Women, boys, and girls will be freely accepted to the membership.

ARTICLE VI MANAGEMENT

The daily affairs of the Corporation are to be managed by the Pastor who serves on a permanent basis, as Minister and Officer or to a person designated by him/her to assist in the management of the corporation.

ARTICLE VII BOARD OF DIRECTORS

The Board of Directors shall be composed of not less than (3) three members. The Board of Advisors shall be elected by the Board of Directors and Members. The Board of Directors and Advisors shall also prepare a set of by-laws for the body of the church organization. The initial

Board of Directors shall be selected by the Pastor and each term thereafter will be voted by the congregation. The Board of Directors and Pastor will propose and prepare the by-laws for the Church
