AMENDING ARTICLE III. MEMBERS - SUBSECTION (D), AS FOLLOWS:

(d) Until seventy-percent (70%) of the units have been sold by the developer as defined in the Declaration of Covenants and Restrictions, the Developer shall have all voting rights in the corporation.
