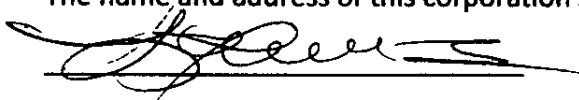

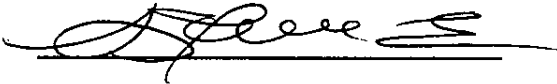
Article NINE

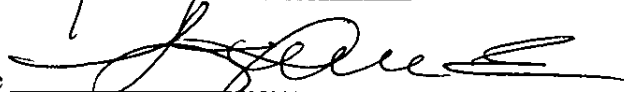
