



ARTICLES OF INCORPORATION
OF

ONE: The name of the corporation shall be TRUE TABERNACLE OF JESUS CHRIST, INC. The Address for the principal office is 1670 S. Congress Avenue; Palm Springs, Florida 33406. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.

TWO: This Corporation is a CHURCH MINISTRY and is not organized for the private gain of any persons. The corporation is organized under the Nonprofit Public Benefit Corporation Law to spread the GOSPEL OF JESUS CHRIST, Charitable, and Educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of but shall not be limited to: Preaching, Ordain Ministers, Officers, and Deacons to work for the Ministry of Jesus Christ, Land Acquisition, Literacy, Counseling, and other programs to aid those in need.

THREE: The duration of this corporation shall be perpetual, and shall have no stock.

FOUR: The name and address of the Registered Agent of the corporation shall be:

FIVE: This Corporation is organized and operated exclusively to Spread the Gospel of Jesus Christ, and Charitable purposes with the meaning of section (501)(c)(3) of the Internal Revenue Code.


SIX: The Directors are elected in accordance with the bylaws. A Director must be 18 years of age or older. The number of Directors shall be three or more.

SEVEN: The property of this corporation is irrevocably dedicated to the promotion of the Gospel of Jesus Christ, Charitable, and Educational purposes and no part of the net income or assets of the organization shall ever inure the benefit of any director, officer or member thereof or the benefit of any private person.

EIGHT: On the dissolution or winding up of the corporation, its assets remaining after payment of or provision for payment of all debts and liabilities of this corporation, which is organized and operated exclusively for the above mentioned purpose (s) on the section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, of shall be distributed to the federal government, or to a state or local government for a public purpose.


