Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendments to its Articles of Incorporation:

PURPOSE OF CORPORATION:

The corporation is organized exclusively for Religious, Charitable, Educational, and Scientific purposes, including, for such purposes, to train Leaders and ordain ministers for the advancement of the kingdom of God and to give assistance to churches and organizations that as exempt organization under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal code.

DISSOLUTION

Upon dissolution of the Corporation, asset shall be distributed for one or more exempt purposes with the meaning of section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to state or local government for public purpose. Any such assets not so disposed of shall be disposed of by court of competent jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such proposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
