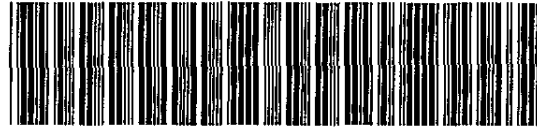

**ARTICLES OF INCORPORATION  
OF  
COMPASSION ACTION FOR HAITIANS, INC.**

The undersigned, desiring to form a not for profit corporation under the provisions of Chapter 617 of the Florida Statutes, certify and acknowledge the following:

**ARTICLE I**

***NAME OF THE ORGANIZATION***

The name of the corporation shall be: **Compassion Action For Haitians, Inc.**

**ARTICLE II**

***THE PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS OF THIS CORPORATION SHALL BE:***

The initial place of business and mailing address of **Compassion Action For Haitians, Inc.** shall be: 4410 Mahogany Run SE, Winter Haven, Florida 33884.

**ARTICLE III**

***PURPOSE***

Compassion Action For Haitians, Inc. is organized for charitable, religious, educational, literary and scientific purposes within the meaning of Chapter 501 (C) (3) of Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue code.

Notwithstanding any other provision of these articles, Compassion Action For Haitians, Inc. will not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under section 501 (C) (3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue Law.

In the event of dissolution, the residual assets of Compassion Action For Haitians, Inc. will be turned in over one or more organizations which themselves are exempt as organizations described in sections 501 (C) (3) and 170 (C) (2) of the Internal Revenue code of 1986 or the corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State or local government for exclusive public purposes.

**ARTICLE IV**

***MANNER OF ELECTION***

The manner in which Directors are elected or appointed is as stated in the Bylaws. The number of directors constituting the initial board of directors of Compassion Action For Haitians, Inc. is seven. The number of Directors may be changed from time to time,
