ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF DEVONSHIRE PARK HOMEOWNERS ASSOCIATION, INC.

ELEVANO PRINCES

Pursuant to Article 10 of the Articles of Incorporation of Devonshire Park Homeowners Association, Inc., the undersigned being the Developer and currently the sole member of the association, hereby adopts the following amendments to the Articles of Incorporation:

1. Articles I, titled "Name and Address of Corporation" is hereby amended and deleted in its entirety and replaced with the following:

"The name of this corporation shall be THE HOMES OF LAUREL PARK HOMEOWNERS ASSOCIATION, INC. (the "Association"). The initial principal office address of the Association is c/o Kirk Pinkerton, P.A., 240 South Pineapple Avenue, 6th Floor, Sarasota, FL 34236 (Attn: Lou Donato)."

- 2. Paragraph 2.1 titled "General Purposes" is hereby amended and deleted in its entirety and replaced with the following:
 - "2.1 General Purposes. The Association is organized for the general purpose of promoting the health, safety, and social welfare of the Owners of Lots located within the subdivision in Sarasota County, Florida (the "Subdivision"), that is hereafter made subject to the terms and provisions of that certain document entitled "Declaration of Restrictions for The Homes of Laurel Park" (the "Declaration"), which is recorded at Official Records Instrument #2006072446, in the Public Records of Sarasota County, Florida, as thereafter amended by the Developer, YYZ Properties, Inc., a Florida corporation ("Developer"). All capitalized words and terms used herein which are defined in the Declaration shall be used herein with the same meanings as defined in the Declaration. In the event of any conflict between the provisions of these Articles of Incorporation and the provisions of the Declaration, the Declaration shall control."
- 3. Paragraph 6.2 titled "Appointment" is hereby amended and deleted in its entirety and placed with the following:
 - "6.2 Appointment. All Directors shall be appointed by Developer until the annual meeting of members in the year 2016. Commencing with such annual meeting and continuing thereafter until the "turnover" meeting of members, Developer shall have the right to appoint a majority of the Directors. Commencing with the "turnover" meeting, all Directors shall be elected by the members in accordance with the provisions of Article 6.3. As used herein, the "turnover" meeting shall mean the first annual or special meeting of members following the date on which members other than Developer, and other builders, contractors, or others who purchase a Lot for the purpose of constructing improvements thereon for resale, for the first time own at

least ninety percent (90%) of the Lots that will ultimately be included in the Subdivision or, if earlier, the date on which Developer, by written notice to the Association, relinquishes its right to appoint a majority of the Directors.

4. Article 11 titled "Registered Office and Registered Agent" is hereby amended and deleted in its entirety and replaced with the following:

"The registered and principal office of the Association shall be c/o Kirk Pinkerton, P.A., 240 South Pineapple Avenue, 6th Floor, Sarasota, FL 34236, and the registered agent at such address shall be Lou Donato. The Association may, however, maintain offices and transact business in such other places within or without the State of Florida as may from time to time be designated by the Board of Directors."
