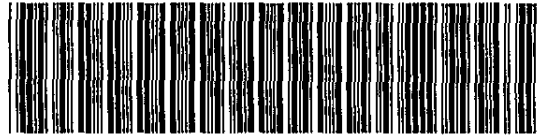

ARTICLES OF INCORPORATION
In Compliance with Chapter 617, F.S. (Not for Profit)

ARTICLE I NAME

The Name of the Corporation shall be: **Colony Cove's "We Care", Inc.**

ARTICLE II PRINCIPAL OFFICE
