# Journey Church Tampa Inc. Amendments to the Articles of Incorporation

- Article III will be changed to:

The specific purpose for which this corporation is organized as stated in By Laws:

- To share and teach the Christian faith and to spread the Gospel of Jesus Christ as revealed through the Holy Scriptures by all means of communication, whether visual, verbal or written.
- The Church is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code.
- To provide for preaching, teaching and fostering the growth of the Christian faith in all places; and to license and ordain ministers; to carry on the work of evangelism; to promote missionary work in all places; to carry on the organization of churches and foster their development and local sovereignty and independence according to this Constitution and its By-Laws.
- To erect and maintain Church buildings, social halls, business offices, school buildings, recreational facilities, and such other structures as are deemed necessary, and to organize and promote such activities as deemed necessary for the upkeep and continuance of said buildings and facilities.
- One Church, multiple gatherings. Journey Church Tampa, Inc. will exist as one church in multiple gatherings apart from some dissolution in a manner consistent with our Bylaws (Article 16). Journey Church Tampa, Inc. will remain one church unified in goal, mission and values while existing in multiple gatherings that are as diverse in some ways as the contexts in which they reside. The elders of each gatherings will work alongside the movement elders and together in a spirit of mutual submission in a manner consistent with our Bylaws.

The manner in which the corporation may be dissolved as stated in By Laws:

#### Dissolution

Dissolution of the ministry will be determined by a unanimous decision of the Movement Eldership of the ministry present at such called special meeting.

#### **Debts**

In the event of the dissolution of the said ministry, the Movement Elders shall pay or make provisions for the payment of all liabilities of the ministry from the assets of the same.

# **Distribution of Funds**

Upon such conditions as above, all remaining assets of the ministry shall be given or distributed to other Christian and or charitable institutions within the city of Tampa in a manner consistent with this provision and the purpose of the ministry and at the direction of the movement eldership.
