

Incompliance with Chapter 617, F.S. (Not for Profit)

ARTICLE I: Name of Corporation

The name of the Corporation shall be RECOVERING FAMILIES, INC.

ARTICLE II: Principal Office

The principal office of the Corporation and the mailing address shall be 5607 Hansel Avenue, Orlando, FL 32809. The Board of Directors may from time to time direct a different principal office or mailing address by appropriate corporate act..

ARTICLE III: Purpose

The purpose of the Corporation shall be exclusively for charitable, educational, religious, or scientific purposes within the meaning of section 501(c)(3) of the Internal Revenue Code.
