Incompliance with Chapter 617, F.S. (Not for Profit)

ARTICLE I : Name of Corporation

The name of the Corporation shall be RECOVERING FAMILIES, INC.

ARTICLE II : Principal Office

The principal office of the Corporation and the mailing address shall be 5607 Hansel Avenue, Orlando, FL 32809. The Board of Directors may from time to time direct a different principal office or mailing address by appropriate corporate act..

ARTICLE III : Purpose

The purpose of the Corporation shall be exclusively for charitable, educational, religious, or scientific purposes within the meaning of section 501(c)(3) of the Internal Revenue Code. To that end, the initial purpose of the Corporation shall be the identification, treatment, and/or prevention of adolescent and young adult substance abuse and the recovery of families impacted thereby.

ARTICLE IV : Manner of Election of Directors

Directors of the Corporation shall be appointed by the Incorporator in the first instance, and after the appointment of the initial Board of Directors, members shall be elected by action of the Board of Directors existing from time to time when a vacancy is to be filled, based on a majority vote. In the event of a tie, such tie shall be broken by the casting of a vote by the President then in office, or if none, by the Incorporator, whether or not such President or Incorporator has already cast a vote as a Director.

ARTICLE VII : Dissolution

Upon dissolution of the Corporation, the Board of Directors shall, after paying or making provisions for the payment of the liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purposes of the corporation, in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under section 501(c)(3) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue law), as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal officer of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
