**A FLORIDA NOT-FOR-PROFIT CORPORATION**

The undersigned incorporate for the purpose of forming a Florida not-for-profit corporation hereby adopts the following Articles of Incorporation:

**Article I**

The name of this corporation is Minority fighting the Aids virus by Grace New hope, Unity and Salvation "Aids Watch Dog Group". Herein acronym and to be called MAGNUS, "AWDG", Inc.

**Article III**

This Organization is organized and operated exclusively for religious, charitable, scientific, literary, educational and faith base activities. Administering HIV/AIDS testing and counseling, intervention and prevention of the HIV/AIDS virus, and to foster HIV/AIDS and Sexually Transmitted Diseases "STD's" awareness in Minority communities. To empower the infected and they're families, with life skills to enable them to combat the ever-changing face of the HIV. To advocate for the HIV/AIDS infected and affected in the State of Florida minority communities. To heighten general consumer protection and awareness of services and goods consumed by the Minority community, bring into action consumer advocacy. MAGNUS, "AWDG", Inc will observe deliberately Governmental allocated funds for HIV/AIDS programs. Monitor and track the HIV/AIDS organizations that access funds via governmental sources in the state of Florida.

Upon the dissolution of the corporation assets shall be distributed for one or more exempt purposes within the meaning of section 501 c (3) of the Internal Revenue Code, or corresponding section of any future tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located. Exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
