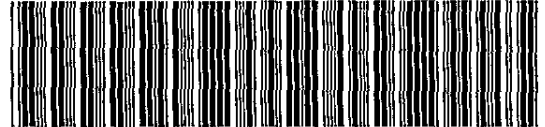

The undersigned, Incorporation for the purpose of forming a **Not for Profit Corporation** under the Florida Business Corporation Act, Chapter 617.0202 (d) of the Florida Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME OF THE ORGANIZATION

The name of the **Not for Profit Corporation** is **THE GREATNESS IN YOU, INC.**, hereafter referred to as the "Corporation".

ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the principal office and the mailing address of the Corporation are

ARTICLE III: PURPOSE OF THE ORGANIZATION

The purpose for which the Corporation is organized is to provide a comprehensive program that will teach young women ages 8-18 how to become the best they can be. This will be done through comprehensive programs that will include, but not limited to, tutoring/mentoring, etiquette, finances, credit, entrepreneurship, college preparation,

volunteerism, and the arts, how to be the best they can be, just to name a few. They will be provided a safe haven after school to express their concerns and have them addressed by professional. This program is also geared toward changing the attitude of young girls before they make choices they will later regret. We will assist them behavioral modification and conflict resolution. The young women will come recommended from local schools and other organizations. In addition, the program will include Conflict Resolution, Anger Management, Teen Pregnancy Prevention/STD Awareness, How to Ask for Help, Counseling Sessions (Individual, Group and Family). This is all in an effort to bring out the greatness in each and every young girl who enters our program.

IV: MANNER OF ELECTION

The CORPORATION shall have five (5) Directors constituting the initial Board of Directors. The other Directors may be either appointed or elected according to the bylaws. The number of Directors may be increased or decreased from time to time by the bylaws.
