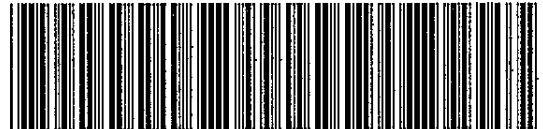

ARTICLES OF INCORPORATION
Of
Community Church of God in Christ of Pompano Beach, Inc.

WE THE UNDERSIGNED, propose to become a religious corporation under the laws of the state of Florida, proving for non-profit religious association, under the charter as follow:

ARTICLE I
Name/Registered Office

The name of the corporation is **Community Church of God in Christ of Pompano Beach, Inc., and located in the State of Florida, County of Broward.**

ARTICLE II
Principal Place of Business

The principle place of business is located at 2250 Martin Luther King Blvd, Pompano Beach, Florida 33069 in Broward County.

ARTICLE III
Purpose

The specific purpose(s) for which the corporation is organized is to establish and operate a church in Broward County, Florida, to buy, manage, and own and hold real and personal property necessary and proper for a place to worship, a school, and to carry on education and charitable work. To continue the spiritual growth of this community. To aid the individual and home in the teaching of the spiritual values of the church.

The organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 ©(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

- A. To combat deterioration of neighborhood with low-income residents;
- B. To provide new housing opportunities that will combat racial and other forms of illegal discrimination in the housing market;
- C. To ease the burdens of government by operating affordable housing program, including specific program initiated at the direction of HUD.
- D. To provide new opportunities for decent, affordable housing, with the goal that a majority of the households benefiting from these opportunities have incomes qualifying for various federally-funded housing program or federal tax incentives for provision of affordable housing.

ARTICLE IV
Manner of election

The terms of admission and qualification for membership in this corporation shall be by application, written or oral, and approved by a majority of the membership. Any person desiring to aid this corporation and interested in religious teaching of the church is eligible to become a member. Specifically, membership shall be determined by the Church's Bylaws.

ARTICLE V
Officers

The officers of this corporation shall be a pastor, treasurer, and secretary. They shall have charge of the temporal affairs to the congregation. There shall be a Board of Trustees which shall consist of not less than three (3) or more than five (5) person elected by the corporation at each annual meeting, and each member so elected shall hold office for one year or at the discretion of the Pastor/President. The Pastor shall be the President of the corporation and a continuous member of the Trustee Board. Vacancies on the Board of Trustee shall be filled by election of the corporation at a special meeting or annual meeting or by Pastor/President appointment. The corporation shall have the power to buy, own, control, and mortgage and manage all personal and real property of the corporation and by the consent of the congregation.

ARTICLE VII
Debt Obligations and Personal Liability

No member, officer or Director of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the members, officers or Directors be subject to the payment of the debts or obligations of this corporation.

ARTICLE VIII

Dissolution

Upon the time of dissolution of the corporation, assets shall be distributed by the Board of Directors, after paying or making provisions for the payment of all debts, obligations, liabilities, costs and expenses of the corporation, for one or more exempt purposes within the meaning of section 501©(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.




