
ARTICLE VIII PROVISIONS

Notwithstanding any powers granted to the Corporation by its Articles of Incorporation, By-Laws or by the laws of the State of Florida, the following limitations of power shall apply:

a. The Corporation is organized for charitable and educational purposes, as that term is used in Section 501 (C) (3) of the Internal revenue Code, as amended, or corresponding section of any future federal tax code.



No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for the services rendered and to make payments and distributions in furtherance of purposes set forth in the purpose clause hereof. The Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of (or in opposition to) any candidate for public office.
