## ARTICLES OF INCORPORATION SECRETARY OF STATE TALLAHASSEE, FLORIDA CRYSTAL MANATEE HOMEOWNERS ASSOCIATION, INC.

The residents, being not less than two-thirds of all the mobile home owners of Suncoast Mobile Home Park, for the purpose of forming a corporation under Florida Statutes 617, do hereby make and adopt the following Articles of Incorporation.

## ARTICLE I. NAME

The name of the corporation is "Crystal Manatee Homeowners Association, Inc."

#### ARTICLE II PRINCIPAL OFFICE

The principal mailing address for this Corporation is - 130 S. Suncoast Blvd. #26, Crystal River, FL 34429.

## ARTICLE III PURPOSE

The Corporation is organized and shall be operated exclusively as a non-stock organization for the following purposes:

- (a) To establish an association of homeowners of mobile homes located at the Suncoast Mobile Home Park in Citrus County, Florida;
- (b) In order to exercise the rights provided in Florida Statutes 723.071 including but not limited to, exercising its right to negotiate for, acquire and operate the mobile home park of Suncoast Mobile Home Park on behalf of the mobile home owners:
- (c) To exercise and engage in any other powers or business of mobile home park associations as permitted by Florida law; and
- (d) To engage in any lawful activities which are in furtherance of the purposes of the Corporation as described herein.

### ARTICLE IV NONSTOCK BASIS

This Corporation is organized on a nonstock basis. This Corporation shall not Issue shares of stock.

## ARTICLE V INITIAL BOARD OF DIRECTORS

The management of the Corporation shall be vested in a Board of Directors. The number of Directors constituting the initial Board of Directors is five (5). The number of Directors may be increased or decreased from time to time in accordance with the bylaws, but shall never be less than three (3). The Members of the Corporation shall elect the Directors as provided in the bylaws. The initial Directors are:
