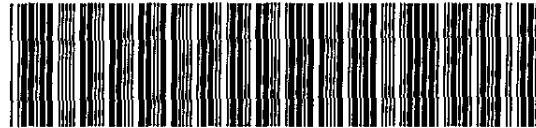

ARTICLES OF INCORPORATION
OF
ROTONDA LAKES CONDOMINIUM I ASSOCIATION, INC.
(A NON-PROFIT FLORIDA CORPORATION)

ARTICLE I.

The name of this corporation is ROTONDA LAKES CONDOMINIUM I ASSOCIATION, INC. The initial principal office of the corporation is 4395 Holly Lake Drive, Lake Worth, FL 33463, and the mailing address of the corporation is 4395 Holly Drive, Lake Worth, FL 33463.

ARTICLE II.

The purpose for which this corporation is organized is to act as the governing association of the proposed ROTONDA LAKES CONDOMINIUMS I, a Condominium, located in Charlotte County, Florida, and to hold title, control, maintain and operate property owned by the Association. The Association shall also operate and maintain the surface water management system facilities, including all inlets, ditches, swales, culverts, water control structures, retention and detention areas, ponds, lakes, floodplain compensation areas, wetlands and any associated buffer areas and wetland mitigation areas.

ARTICLE III.

The terms used in these Articles of Incorporation shall have the same definitions and meanings as those set forth in the Declaration of Condominium of ROTONDA LAKES CONDOMINIUMS I, a Condominium.

ARTICLE IV.

The Association shall have all of those powers granted by The Florida Condominium Act and The Florida Not-for-Profit Corporations Act, including, but not limited to, the power to establish rules and regulations for ROTONDA LAKES CONDOMINIUMS I, a Condominium, the power to assess members and to enforce those assessments pursuant to ROTONDA LAKES CONDOMINIUMS I Declaration of Condominium, to sue and be sued, to contract for services to provide for the operation and maintenance of the surface water management system facilities of the Association contemplates employing a maintenance company and to take any other action necessary for the purpose for which the Association is organized.

ARTICLE V.

The qualification of members and the manner of their admission shall be as follows: Any person or persons who hold title in fee simple to a condominium unit in ROTONDA LAKES CONDOMINIUMS I, a Condominium, shall by virtue of such ownership be a member of this corporation.

ARTICLE VI.

This corporation shall exist perpetually. However, in the event the Association is dissolved, the control or right of access to the property containing the surface water management facilities shall be conveyed or dedicated to an appropriate governmental unit or entity and that if not accepted, then the surface water management system facilities shall be conveyed to a not-for-profit corporation similar to the Association.

ARTICLE VII.

The names and residences of the subscribers to these Articles of Incorporation are as follows:

ARTICLE VIII.

The affairs of the corporation are to be managed by a Board of Directors, the number of members of which shall be as provided in the Bylaws provided that there shall be not fewer than three and not more than seven. The Directors will be elected each year at the annual meeting of the Condominium Association as provided for in the Bylaws, subject to the rights of the Developer and unit owners to elect directors as provided in Section 718.301, Florida Statutes (2006), and in ROTONDA LAKES CONDOMINIUM I Declaration of Condominium.

ARTICLE IX.

The names of the officers who are to serve until the first election or appointment under the Articles of Incorporation are:

ARTICLE XI.

The Bylaws of the corporation are to be made, altered or rescinded by the members of the corporation as provided for in the Bylaws.

ARTICLE XII.

Amendments to these Articles of Incorporation may be proposed and adopted at any regular or specially called meeting of the members of the Association by a majority vote of all the members. Due notice of the meeting must have been given as provided for in the Bylaws. Also, the Developer may amend these Articles of Incorporation, and its approval shall be required for amendments, in the manner provided in ROTONDA LAKES CONDOMINIUM I, Declaration of Condominium.

ARTICLE XIII.

Each unit in ROTONDA LAKES CONDOMINIUM I, a Condominium shall have one (1) full vote, which shall be cast by a designated owner as provided for in the Declaration of Condominium or Bylaws.

ARTICLE XIV.

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation.

ARTICLE XV.

No part of the net earnings of this corporation shall inure to the benefit of any member or individual, except through the acquisition, construction, management, maintenance, or care of association property or through the rebate of the excess membership dues, fees, or assessments.
