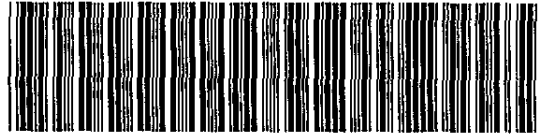

**ARTICLES OF INCORPORATION**

**For  
New Church Today, Inc.  
A Florida "Not for Profit" Corporation**

The Articles of Incorporation of the undersigned, whom are citizens of the United States, desiring to form a Not for Profit Corporation under the Not for Profit Corporation Law of the State of Florida, do hereby certify:

**ARTICLE I      NAME**

The name of the corporation shall be New Church Today, Inc.

**EFFECTIVE DATE**  
03-01-06

**ARTICLE II      PRINCIPAL OFFICE AND MAILING ADDRESS**

The principal office of this corporation shall be 435 Willow Lane, Melbourne, FL 32925. The mailing address is PO Box 560945, Rockledge, FL 32956-0945.

**ARTICLE III      CORPORATE PURPOSES**

The purposes for which this corporation is formed are exclusively religious, educational, and charitable and include the following:

1. To further the will of God on Earth, through the teachings of Jesus the Christ, however and whenever possible, by teaching, publishing, promoting, sharing and exemplifying the love of God and its transforming power, to the best of our ability and understanding, and, particularly when standing as representatives of this ministry, as described in the sacred and wisdom writings of the Bible and other texts.
2. To create a spiritual home for our members and all who attend (defined as the congregation) by providing weekly worship services, prayer and meditation services, chaplains, educational children's programs, classes to further spiritual growth, weddings, baptisms, and funerals, and other programs and services as necessary to serve as a church.
3. To create an opportunity for our congregation to serve each other, and the local and global communities through spiritual, educational, and charitable means. To be an instrument in hastening the coming of true peace and brother hood on Earth and a broader revelation of divine truth. We will ally with and support other spiritual and civic organizations, and like-minded groups, locally and globally, that are aligned with our purpose.
4. To achieve any other objectives that may be determined by the Board of Directors, we will manage our church using spiritual principles, staying closely connected with God who is our Source in creating the New Church Today, Inc.
5. To do any and all lawful activities which may be necessary, useful, or desirable for the furtherance, accomplishment, fostering, or attaining of the foregoing purposes, either directly or indirectly, and either alone or in conjunction or cooperation with others, whether such others be persons or organizations of any kind or nature, such as corporations, firms, association, trusts, institution, foundations, or governmental bureaus, departments or agencies.
6. To operate solely for religious, educational and charitable purposes and in such a manner that the Corporation will qualify as an exempt organization under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future federal tax code.
  - a. Notwithstanding any other provision of these articles, this organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from state tax or from federal income tax under section 501 (c)(3) of the Internal Revenue Code, or the corresponding provision of any

future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

b. The Corporation is organized exclusively for religious, charitable, and educational purposes.

c. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above. The property, assets, profits and net income of the Corporation are irrevocably dedicated to religious, charitable, and educational purposes, no part of which shall inure to the benefit of any individual.

d. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

e. Upon the dissolution of the corporation, the assets of the Corporation remaining after payment of all debts and liabilities shall be distributed to an organization recognized as exempt under section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future federal tax code, to be used exclusively for charitable, religious, and educational purposes. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

**ARTICLE IV MANNER OF ELECTION OF DIRECTORS**

The method of selection of the Board of Directors and number of Directors shall be stated in the bylaws.

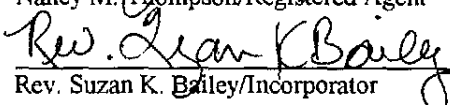
**ARTICLE VIII DATE OF INCORPORATION**
