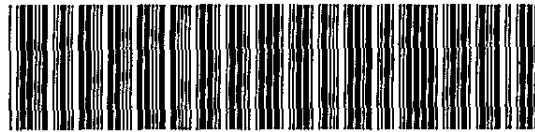

ARTICLES OF INCORPORATION

The undersigned as the incorporator of the BRIGHTER LIFE PRISON YOUTH MISSIONS, INC., promulgates the following Articles of Incorporation for such corporations pursuant to the State of Florida "Not for Profit" Corporations Act.

1. The name of this corporation shall be the BRIGHTER LIFE PRISON YOUTH MISSIONS, INC.
2. That initial mailing address of this corporation shall be c/o Martha Garris, P.O. Box 311271, Tampa, Florida 33680, and the street address shall be 4502 N. 34th Street, Tampa, Florida.
3. The purpose for which the corporation is organized is to furnish outreach and support services to youthful inmates of prisons in the State of Florida.
4. This corporation shall exist perpetually.
5. The initial incorporator is Howard L. Garrett, 3314 Henderson Boulevard, Suite 208, Tampa, Florida 33609-2934.
6. The initial Registered Agent of this corporation shall be Howard L. Garrett, 3314 Henderson Boulevard, Suite 208, Tampa, Florida 33609-2934.
7. The directors shall consist of not less than three (3) nor more than eleven (11) persons. They shall be elected annually by the members of the corporation; provided however that a Board, in its judgment may add members from time to time to the Board provided however the total shall not exceed eleven (11) in number.
8. The street address of the initial registered office shall be 3314 Henderson Boulevard, Suite 208, Tampa, Florida 33609-2934, and the initial registered agent shall be

Howard L. Garrett. The initial directors are as follows: Martha Garris, 4502 N. 34th Street, Tampa, Florida; Johnny Garris, 4502 N. 34th Street, Tampa, Florida; Cynthia Ferguson, 4502 N. 34th Street, Tampa, Florida and Valerie Chambers, 4502 N. 34th Street, Tampa, Florida.

9. Membership may be terminated voluntarily by any member, or by a majority vote of the Board of Directors.

10. No member shall have any right, title, interest, claim or demand to the assets of corporation.

11. On the dissolution of this corporation voluntarily, or by operation of the law, the assets shall be delivered up unto any organization chosen by the Board of Directors which has exemption under *Sec. 501(c)(3) of the Internal Revenue Laws of the United States of America*.

12. The corporation shall have all powers authorized by the laws of the State of Florida.

13. The corporation shall become effective upon these Articles of Incorporation being filed with the appropriate agency of the State of Florida.
