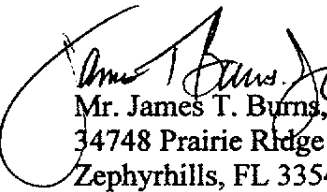

ARTICLE I NAME

The name of the corporation shall be the RBS Middle School Band Boosters, INC.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 38505 10th Avenue, Zephyrhills, Florida 33542.

ARTICLE III PURPOSE

The purpose for which the corporation is organized is to enlist the cooperation of parents, the school and the community at large to actively support and promote the band program and Band Director of Raymond B. Stewart Middle School to facilitate a successful and educational band for all students, provide support unattainable from Pasco County School Board, and to assist the Band Director.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed shall be as follows:

1. Qualifications for Office: Those persons nominated for positions on the Board of Directors shall be active members of the Boosters and willing to serve.
2. Election Procedure: The Board of Directors shall be elected by a majority vote of the Active membership present during the regular membership meeting in April of each year. Parents of incoming students will be invited to the March meeting of the Boosters for the purpose of presenting their names for the upcoming election. The President shall call for additional nominations from the floor at the April meeting, but no name shall be placed in nomination without the consent of the nominee.
3. Only one (1) adult member of a family may serve on the Board of Directors at any one time.
4. Vacancies shall be filled by appointment of the President from Active Boosters.

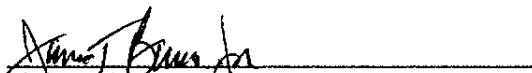
