ARTICLE III - PURPOSES - IS AMENDED AND REPLACED IN IT'S ENTIRETY AS FOLLOWS:

THE GENERAL PURPOSE OF THE ORGANIZATION IS TO OPERATE A CHARITABLE
ORGANIZATION WITHIN THE MEANING OF SECTION 501(c)(3) OF THE INTERNAL REVENUE CODE
OF 1986, OR THE CORRESPONDING PROVISION OF ANY FUTURE UNITED STATES INTERNAL
REVENUE LAW THERETO. THE SPECIFIC PURPOSE FOR WHICH THIS ORGANIZATION EXISTS
IS TO OPERATE A CHRISTIAN CHURCH. THE CHURCH WILL BE OPERATED IN A MANNER
CONSISTENT WITH THE CHARACTERISTICS ATTRIBUTED TO CHURCHES BY THE INTERNAL REVENUE
SERVICE AND BY COURT DECISIONS RECOGNIZED BY THE INTERNAL REVENUE SERVICE REGARDING
SUCH CHARACTERISTICS. SUCH CHARACTERISTICS INCLUDE: A DISTINCT LEGAL EXISTENCE,
A RECOGNIZED CREED AND FORM OF WORSHIP, A DEFINITE AND DISTINCT ECCLESIASTICAL
GOVERNMENT, A FORMAL CODE OF DOCTRINE AND DISCIPLINE, A DISTINCT RELIGIOUS HISTORY,
A MEMBERSHIP NOT ASSOCIATED WITH ANY OTHER CHURCH OR DENOMINATION, AN ORGANIZATION
OF ORDAINED MINISTERS, ORDAINED MINISTERS THAT ARE SELECTED AFTER COMPLETING A
PRESCRIBED COURSE OF STUDY, LITERATURE OF ITS OWN, AN ESTABLISHED PLACE OF WORSHIP,
REGULAR CONGREGATIONS, REGULAR RELIGIOUS SERVICES, SUNDAY SCHOOLS FOR THE
RELIGIOUS INSTRUCTION OF THE YOUNG AND SCHOOLS FOR THE PREPARATION OF ITS MEMBERS.


