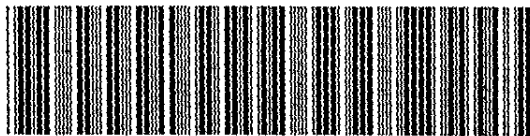

ARTICLE I. NAME OF CORPORATION

The name of this corporation shall be: My Business Clubs, Inc.

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III. PURPOSE

The purpose for which the corporation is organized is: to provide employability training; college entrance preparation; entrepreneurship education; personal and business finance instruction; educational financial aid; work experiences; and business planning and marketing support for disadvantaged teenagers and young adults seeking to start a small business or otherwise further their earnings potential. The means of providing such services shall include, but not be limited to, classes, workshops and lectures; newsletters and other publications; and internships and self-employment experiences. Furthermore, the corporation shall sponsor fund raising activities and events, and solicit grants and other funds from public and private sources for the purpose of providing its services.

This corporation is organized and operated for charitable and educational purposes for the benefit of the general public, especially underprivileged teenagers and young adults, within the meaning of 501(c)(3) of the Internal Revenue Code.

ARTICLE IV. MANNER OF ELECTION

The manner in which the directors are elected or appointed: shall be stated in the bylaws of the corporation.

ARTICLE VI. DISSOLUTION OF ASSETS

The property of this Corporation is irrevocably dedicated to educational purposes. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision of payment, of all debts and liabilities shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for educational purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.

ARTICLE VII. LIMITATION ON POLITICAL ACTIVITIES

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

ARTICLE VIII. LIMITATION ON PRIVATE INUREMENT

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

ARTICLE IX. LIMITATION ON ACTIVITIES

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.




