ARTICLE I NAME

The name of the corporation shall be:

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

Said Corporation is organized exclusively for charitable, religious, educational, literary and scientific purposes under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Specifically, Simply Summer Community Development Corporation will:

- 1. Engage in activities designed to raise the economic welfare, educational and social levels of the underprivileged or low and moderate income residents throughout the State of Florida, but primarily in Miami-Dade County;
