

#### PLAN OF MERGER

PUERTO DEL RIO, PHASE ONE CONDOMINUM ASSOCIATION, INC. (a Florida Not For Profit Corporation) ("Phase One") with and into

PUERTO DEL RIO, PHASE THREE CONDOMINIUM ASSOCIATION, INC. (a Florida Not For Profit Corporation) ("Phase Three")

THIS PLAN OF MERGER is made as of the date set forth below by and between Puerto Del Rio, Phase One Condominium Association, Inc., a Florida not for profit corporation and Puerto Del Rio, Phase Three Condominium Association, Inc., a Florida not for profit corporation (the "Surviving Corporation").

- 1. Phase One shall merge with and into Phase Three (the "Merger") and the Surviving Corporation shall exist by virtue and under the laws of the State of Florida. The Surviving Corporation and its identity, existence, purpose, powers, franchises, rights and immunities of a not for profit corporation are unaffected and unimpaired by the Merger, and the corporate identity, existence, purpose, powers, franchises, rights and immunities of Phase One shall be merged with and into the Surviving Corporation and the Surviving Corporation shall be fully vested therewith. The separate existence of Phase One, except insofar as it may be continued by reason of Florida law, shall cease upon the Merger becoming effective and thereupon Phase One and the Surviving Corporation shall become a single not for profit corporation.
- 2. At the Effective Time (as defined below), the Articles of Incorporation of Phase Three, as in effect immediately prior to the Effective Time, shall be the Articles of Incorporation of the Surviving Corporation.
- 3. At the Effective Time, the By-Laws of Phase Three, as in effect immediately prior to the Effective Time, shall be the By-Laws of the Surviving Corporation until otherwise altered, amended or terminated.
- 4. At the Effective Time, each of the membership interests of Phase Three shall remain and each member of Phase One shall become a member of the Surviving Corporation, without any action on the part of the member.

5. At the Effective Time, the Board of Directors and Officers of Phase Three immediately prior to the Effective Time shall be the Board of Directors of the Surviving Corporation, to hold office in accordance with applicable law and the Articles and By-Laws of the Surviving Corporation.
