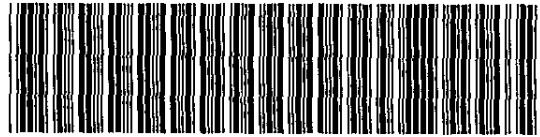

ARTICLES OF INCORPORATION

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Florida, do hereby certify:

Article I: The name of the Corporation shall be:

DAVID LUGO MINISTRIES INC

Article II: The principal place of business and mailing address of this corporation shall be: 1680 SW Bascom Ave.; Port St. Lucie, FL 34953.

Article III: Said corporation is organized exclusively for religious purposes, specifically to fulfill the Great Commission of Christ, to be builders of faith, righteousness and grace, to bring change to the community, and to lift up the name of Jesus, so that all men will be drawn unto Him.

Article IV: The names and addresses of the persons who are the initial officers of the corporation are as follows:

President, Treasurer:

Article V: Future directors shall be appointed by the President of the corporation.

Article VI: The initial Registered Agent shall be Jackie Lugo, whose address is 1680 SW Bascom Ave.; Port St. Lucie, FL 34953

Article VII: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c)(3) of

the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article VIII: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state of local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article IX: The name of the Incorporator is Laura Sivalia whose address is 1205 W. Midway Rd., Fort Pierce, FL 34982

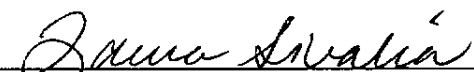
