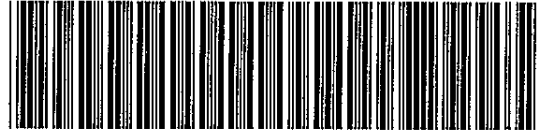

WOODBIDGE AND ALTAMONTE COMMUNITY CEMETERY INC

In Compliance with Chapter 617.F.S., (Not for Profit)

ARTICLE I

Article of Incorporation of the undersigned a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify.

The name of the Corporation shall be WoodBridge and Altamonte Community Cemetery Inc.

ARTICLE II

The place in this state where the principal office of the Corporation is to be located in the City of Altamonte Springs, Seminole County.

The principle mailing address shall be: 110 Spring Street
Altamonte Springs, FL 32701

ARTICLE III

Said Corporation is organized exclusively for charitable purposes. The purpose of the WoodBridge and Altamonte Community Cemetery Inc. shall be to promote communication an involvement among families of WoodBridge and Altamonte Community Cemetery Inc. The WoodBridge and Altamonte Community Cemetery Inc., will serve in an advisory capacity to the cemetery community and to assist in the development of the cemetery and in the preparation and evaluation of improvements. The WoodBridge and Altamonte Community Cemetery Inc., shall not assume any of the power and duties of the families.

ARTICLE IV

The manner in which the officers/trustee are elected is by nomination with a majority approval.

ARTICLE VI

No part of the net earnings of the WoodBridge and Altamonte Community Cemetery Inc., shall benefit or distributable to its members, trustees, officers, or other private persons, except that of WoodBridge and Altamonte Community Cemetery Inc., shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the WoodBridge and Altamonte Community Cemetery Inc., shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the WoodBridge and Altamonte Community Cemetery Inc., shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the WoodBridge and Altamonte Community Cemetery Inc., shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VII

Upon the dissolution of the WoodBridge and Altamonte Community Cemetery Inc., Assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal

office of the WoodBridge and Altamonte Community Cemetery Inc., is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
