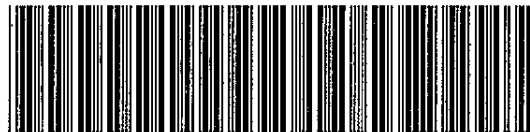

PURSUANT TO THE PROVISIONS OF SECTION
617.4006, FLORIDA STATUTES, THIS FLORIDA
NOT FOR PROFIT CORPORATION ADOPTS THE
FOLLOWING AMENDMENT(S) TO ITS ARTICLES
OF INCORPORATION:

"THIS CORPORATION IS ORGANIZED EXCLUSIVELY FOR
CHARTABLE PURPOSES WITHIN THE MEANING OF
SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE,
NOT WITHSTANDING ANY OTHER PROVISIONS OF THESE
ARTICLES, THE CORPORATION SHALL NOT CARRY ON
ANY OTHER ACTIVITIES NOT PERMITTED TO BE CARRIED
