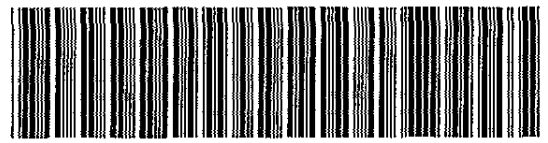

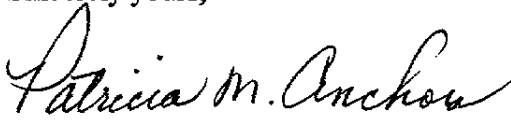

ARTICLES OF INCORPORATION  
OF  
CROSSROADS ASSEMBLY OF GOD, INC.

ARTICLE I.

Name

The name of this corporation shall be: Crossroads Assembly Of God, Inc., a  
non-profit religious corporation.

ARTICLE II.

Principal Place of Business

ARTICLE III..

Purpose

The purpose of this corporation is:

1. To be an agency of God for evangelizing the world (Acts 1:8; Matthew 28:19,20;  
M ark 16:15, 16).
2. To be a corporate body in which man may worship God (1 Corinthians 12:13)
3. To be a channel of God's purpose to build a body of saints being perfected in the  
image of His son (Ephesians 4:11-16; 1 Corinthians 12:28; 14:12).
