

Amendment 2, To Articles of incorporation of the Pete Renner Foundation Inc.

Art. III. The Specific purpose for which this corporation is organized is; Provide financial assistance to Families in need, where the need is the direct result of a medical condition. Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under sections 501 (c) (3) of the internal Revenue code, or the corresponding section of any future federal tax code.

No part of the net earnings of the Pete Renner Foundation Inc. shall insure to the benefit of, or be distributable to it's members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for the services rendered and make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the Pete Renner Foundation Inc. shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Pete Renner Foundation Inc. shall not participate in, or intervene in (including the publishing or distribution of statements) and any political campaign on behalf of any candidate for public office. Not withstanding any other provision of this document, the Pete Renner Foundation shall not carry on any other purposes not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the Pete Renner Foundation Inc., assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the Court of Common pleas of the county in which the principal office of the Pete Renner Foundation Inc. is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.
