AMENDMENTS TO THE ARTICLES OF INCORPORATION OF PROMENADE AT TRADITION COMMUNITY ASSOCIATION, INC.

As used herein the following shall apply:

- A. Words in the text which are lined through with hyphens (----) indicate deletions from the present text.
- B. Words in the text which are <u>underlined</u> indicate additions to the presert text.
- 1. Section 5 of the Articles of Incorporation shall be amended to read as follows:
 - "5. Purpose of Association. Association is formed to: (a) provide for the ownership, operation, maintenance and preservation of the Common Areas, and improvements thereon, including without limitation the Surface Water Management System; (b) perform the duties delegated to it in the Declaration; (c) administer the interests of Association and the Owners; and (d) promise the health, safety and welfare of the Owners and to operate Promenade at Tradition No. I and created by the Declaration of Condominium recorded in Official Record Book 2617, Page 2438, to operate Promenade at Tradition No. II and created by the Declaration of Condominium recorded in Official Record Book 2585, Page 2930, to operate Promenade at Tradition No. III and created by the Declaration of Condominium recorded in Official Record Book 2549, Page 389 and to operate Promenade at Tradition No. IV and created by the Declaration of Condominium recorded in Official Record Book 2506, Page 1090."
- 2. A new Section 7.16 shall be added to the Articles of Incorporation and shall read as follows:
 - "7.16 Those powers of the Association include those as set forth in the Declarations of Condominium as referenced in Section 5 of these Articles."
- 3. Section 9 of the Articles shall be amended to read as follows:
 - "9. Board of Directors. The affairs of Association shall be managed by a Board of Directors of edd number with not less than three (3) nor more than five (5) members. The initial number of Directors shall be three (3). Board members shall be appointed and/or elected as stated in the By-Laws. The election of Directors shall be held at the annual meeting of the
