ARTICLES OF INCORPORATION (Not for Profit) OF

SW LEVY YOUTH SPORTS ORGANIZATION, INC

ARTICLE I. CORPORATE NAME

The name of the corporation shall be SW Levy Youth Sports Organization, Inc.

ARTICLE II. PRINCIPAL OFFICE
