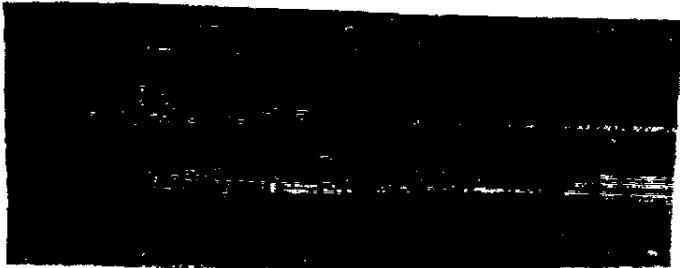

2B. Bible Teachers International-Indiantown, Inc. is organized in compliance with Chapter 617, F. S., ( Not for Profit)

3A. Initial Registered Office and Agent

1B. This corporation shall not have members, shareholders, or capital stock.

2B. No trustee, director, officer or other individual shall at any time have any interest in the earnings or income of the corporation, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered to or for the corporation and to make payments and distributions in furtherance of the purposes set forth in Article 7A.1B hereof.

7A. Mission Statement and Powers

- 1B. Bible Teachers International-Indiantown, Inc. is a religious, educational, scientific, literary and charitable organization within the meaning of Internal Revenue Service Code Section 501(c) (3) dedicated to ministering revival and discipleship to the church through ministry, training, counseling, education and discipleship, and any other lawful activity.
- 2B. The said corporation shall have all the rights and powers customary and proper for charitable organizations, including those specifically enumerated in Chapter 617, of the Florida Revised Statutes (Nonprofit Corporation Law), but not to include any powers or activities not permitted to be carried on by
  - 1C. a corporation exempt from Federal Income Tax under Section 501 (c) (3)
  - 2C. a corporation contribution to which is deductible under Section 170(c) (2) of the Internal Revenue Code of 1954 or any corresponding provisions of any future United States Internal Revenue law.
- 3B. The Board of Directors by majority vote shall have the power to adopt and amend all laws and by-laws, not inconsistent with Articles of Incorporation, the laws of this State, or of the United States, for the administration and regulation of the affairs of the corporation.

8A. Officers and Board of Directors

- 1B. Board of Directors
  - 1C. The management and regulation of Bible Teachers International Inc., shall be governed by a board of directors and such officers as may be appointed by said directors.
  - 2C. The number of directors shall be at least three (3) but not more than twelve (12). The exact number shall be determined at the discretion of the existing directors.
  - 3C. The Board of Directors shall include the officers of the Corporation.

- 9A. Liability of Directors and Officers
- 1B. Any officer or director of the corporation shall not be liable for any monetary damages to the corporation for any breach of fiduciary duty. The corporation shall indemnify all officers and directors for all acts performed during or as a result of their duties for and on behalf of the corporation provided that such indemnification shall not conflict with the laws of the State of Florida
- 10A. Dissolution of Corporation
- 1B. The Board of Directors may, by unanimous vote, cease corporate activities and surrender the corporate franchise.
- 2B. In the event of dissolution of Bible Teachers International, Inc, the distribution of corporate assets shall be decided by majority vote of the Board of Directors under the provisions outlined below.
- 1C. The residual assets of the corporation shall be turned over to one or

more organizations which themselves are exempt as organizations described in Sections 501 (c) (3) and 270 (c) (2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future Internal Revenue Code.

2C. Disposition of assets shall be further governed by the article covering the details of succession in the By-Laws.
