ARTICLE I NAME

The name of the corporation shall be: Charity Gateway Partners, Inc.

The purpose for which the corporation is organized is:

The Purpose of the agency is to bring case management and life sustenance services to underserved, low-income, and disabled clients in need who reside in small town and rural settings.

ARTICLE IV DISSOLUTION

Upon the dissolution of this corporation, all capital and cash assets will be dispersed to the WellFlorida Council to be used for charitable purposes, and to complete any pending obligation of Charity Gateway Partners to clients or services. In the event that WellFlorida Council has also been dissolved, all capital and cash assets should revert to 2nd Harvest Food Bank, for purchase of food for distribution to those agencies that provide direct food pantry help to poor and disadvantaged people.
