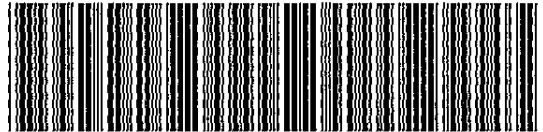





AMENDMENTS TO THE ARTICLES OF INCORPORATION OF  
THUNDERATION OWNERS' ASSOCIATION, INC.

Article V of the Articles of Incorporation of the Thunderation Owners' Association, Inc. is hereby amended as follows, with the balance of said Article remaining unaltered, (note that additions are indicated by underlining and deletions are indicated by ~~strikeouts~~):

ARTICLE V

PURPOSE AND POWERS OF THE ASSOCIATION

The Association shall have all of the common law and statutory powers of a corporation not-for-profit and homeowners association under the laws of the State of Florida, and shall have the powers and duties to administer, enforce, carry out and perform all of the acts, functions, rights and duties provided in, or contemplated by, the Declaration, including but not limited to, the following:

...

9. To employ personnel necessary to perform the obligations, services and duties required of or to be performed by the Association and for proper operation of the properties for which the Association is responsible, or to contract with others for the performance of such obligations, services and duties; ~~and~~
10. To sue and be sued; and
11. Operate and maintain the surface water management system facilities, including all inlets, ditches, swales, culverts, water control structures, retention and detention areas, ponds, lakes, floodplain compensation areas, wetlands and any associated buffer areas, and wetland mitigation areas.
