**THIS AMENDMENT TO THE ARTICLES OF INCORPORATION OF THUNDERATION OWNERS' ASSOCIATION, INC. AND TO THE BYLAWS OF THUNDERATION OWNERS' ASSOCIATION, INC.**, a Florida not-for-profit corporation (hereinafter "the Association"), is executed this 6<sup>th</sup> day of FEBRUARY, 2009.

**WHEREAS**, the Articles of Incorporation (hereinafter the "Articles") and Bylaws (hereinafter the "Bylaws") of THUNDERATION OWNERS' ASSOCIATION INC. were filed with the State of Florida on March 24, 2006; and

**WHEREAS**, the Articles and Bylaws may be amended in accordance with the terms stated therein from time to time; and

**NOW THEREFORE**, the Articles and Bylaws shall be amended as follows:

1. Wheresoever in the Articles the Thunderation Owners' Association, Inc. is referenced, it shall refer to the CORAL VISTA PROPERTY OWNER'S ASSOCIATION, INC., which shall hereinafter be the name of the Association.

2. Wheresoever in the Bylaws the Thunderation Owners' Association, Inc. is referenced, it shall refer to the CORAL VISTA PROPERTY OWNER'S ASSOCIATION, INC., which shall hereinafter be the name of the Association.

3. This Amendment is made pursuant to Article XI of the Articles and Article XII of the Bylaws, and except as modified and amended by the terms hereof, the Articles and Bylaws shall remain in full force and effect as if fully restated herein. If any provision of this Amendment conflicts with any provision of the Articles or Bylaws, the provision in this Amendment shall prevail.

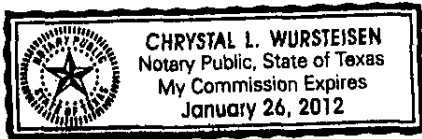
