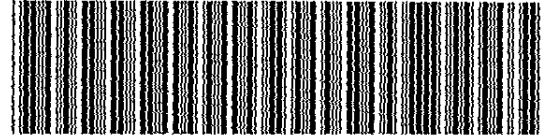

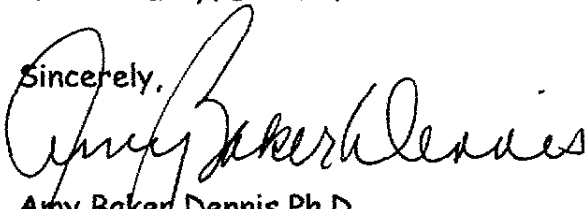

ARTICLES OF INCORPORATION

ARTICLE I: NAME

The name of the corporation shall be: *Eating Disorder Network of Central Florida, Inc.*

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III: PURPOSE

The purpose for which the corporation is organized is: *Eating Disorder Network of Central Florida is a multi disciplinary group of health and mental health professionals dedicated to providing quality treatment to individuals and families suffering from eating disorders. The network is committed to increasing professional and community awareness to allow for early detection and intervention. The network will strive to promote peer support professional development.*

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV: MANNER OF ELECTION

The manner in which the directors are elected or appointed:

Elections will be held annually to replace officers that are up for election. The membership will nominate candidates for each office. An e-mail vote will be conducted and managed by the Past President of the Organization, except if the Past President is running for office. If this is the case an officer, not running for re-election will be appointed by the President to manage the election process. In case an officer or committee chair needs to be replaced mid-term, the president will call a special election to fill the open position.

ARTICLE VI –NOT-FOR-PROFIT

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE VII: DISSOLUTION OF ASSETS

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
