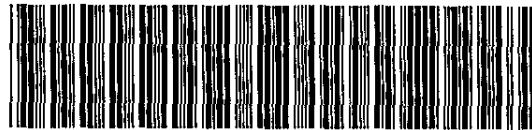

**ARTICLES OF INCORPORATION**

***Article I***

*The name and address of this principal corporation is **Deshama's Answering Service, Inc.**, located at 503 Legion Terrace, Starke, Florida 32091, in Bradford County. The principal office is also the mailing address. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.*

***Article II***

*This Corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. This corporation is organized under the Nonprofit Public Benefit Corporation Law to: operate exclusively for charitable, and educational purposes. To aid the poor and disadvantaged Individuals and families toward a life of self-sufficiency. This program will consist of but shall not be limited to: Training, Land Acquisition, Adult Business Skills, Counseling, Tutoring, summer Camp, After School Care, Music, Life Skills, Community Employment, GED Testing, Computer Labs, Seminars, Reading, English, Math, Banking, Finances & Investments, Abstinence, Development, Health Fairs, Aids/HIV Education, Drug Awareness, Rehabilitation of clients back into society, and other programs to aid those in need.*

***Article III***

*The duration of the corporation shall be perpetual, no stock and shall have no members.*

***Article IV***

*The address of the registered office is: 503 Legion Terrace, Starke, Florida 32091, and The name and address of the registered agent of the corporation shall be:*

***Article V***

*(a) This corporation is organized and operated exclusively for Educational and Charitable purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from Federal income tax under Section 501 c 3 of the Internal Revenue code.*

or (2) by a corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.

#### **Article VI**

#### **Article VII**


*The property of this corporation is irrevocably dedicated to Charitable and Educational purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer ore member thereof or any private person.*

#### **Article VIII**

*On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payments of, all debts, and liabilities of this corporation, shall be distributed to a non-profit fund, foundation, or corporation, shall be distributed to a non-profit fund, foundation, or corporation, which is organized and operated exclusively for Educational and Charitable under Section 501 © (3) of the Internal Revenue Code, or corresponding section of any future government, or to a state or local government for a public purpose. Any such asset not disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such organized and operated exclusively for such purposes.*
