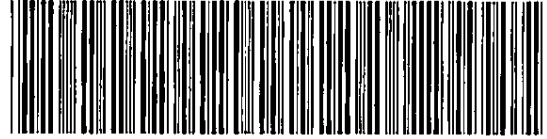

AMENDED AND RESTATED ARTICLES OF INCORPORATION

Pursuant to Section 617.1006 and Section 617.1007, Florida Statutes, and the laws of the State of Florida, the Articles of Incorporation of El Shaddai of Grace Church Inc., a Florida not-for-profit corporation, are hereby amended and restated in their entirety, as set forth herein.

These Amended and Restated Articles of Incorporation ("Articles") were duly-adopted in the name of God by the Session and the members of the congregation, effective as of August 24, 2023, and the number of votes cast for approval of these Articles was sufficient.

ARTICLE I. NAME AND ADDRESS

The name of this Florida not-for-profit corporation shall be "El Shaddai of Grace Church Inc.", herein referred to as the "Church". The principal office and mailing address of the Church shall be 6750 Golden Gate Parkway, Naples, Florida 34105.

ARTICLE II. PURPOSE AND POWERS

The object and purpose of the Church shall be to worship God and proclaim the Gospel of Jesus Christ in accordance with the doctrinal, governmental, and disciplinary standards of El Shaddai of Grace Church Inc., as more particularly set forth in the Bylaws of the Church ("Bylaws"). The Church shall have all powers set forth in the Bylaws and Chapter 617, Florida Statutes.

ARTICLE III. MEMBERSHIP

Membership in the Church is open to any person upon the recommendation of, and by vote of, the Session, as more particularly set forth in the Bylaws.

ARTICLE IV. TERM; DISSOLUTION

- A. Term. The term of the Church shall be perpetual.
- B. Dissolution. Any dissolution of the Church shall be in accordance with the applicable provisions of the Bylaws and Chapter 617, Florida Statutes.

ARTICLE V. BOARD OF TRUSTEES AND SESSION

- A. Board of Trustees. The affairs of the Church shall be conducted and governed by a Board of Trustees ("Trustees"). The Trustees, as corporate officers of the Church, shall be members of, and elected annually by, the Session, all in accordance with the Bylaws. The Trustees shall have charge of all Church property, real and otherwise, and shall be entrusted with such responsibility as provided in the Bylaws and Chapter 617, Florida Statutes. The names, titles, and addresses of the current Board of Trustees are as follows:

B. Session. The governing body of the Church shall be the Session. The Session shall be comprised of, and its members elected in accordance with, the provisions of the Bylaws.

ARTICLE VI. BYLAWS

The Bylaws shall be adopted by the Session and may be altered, amended, or rescinded in the manner provided therein.

ARTICLE VII. AMENDMENT

Any amendment, rescission, or revision of these Articles shall be accomplished by a two-thirds majority of the members of the Church present and voting at any meeting duly-called for such purpose. Notice of said meeting shall be provided to the members of the Church by announcement from the pulpit during all worship services not less than fourteen (14) days prior to the date of the meeting and, in the judgment of the Session, communicated to the members of the Church through usual and ordinary channels of communication.

ARTICLE VIII. REGISTERED AGENT AND OFFICE

The current registered agent of the Church is Pastor Sainvil Dorsainvil, and the street address of the registered office of the Church is 4251 45th Ave NE, Naples, FL 34120. The Church shall have the right to change such registered agent and office from time to time as provided by law.


ARTICLE IX. MISCELLANEOUS
