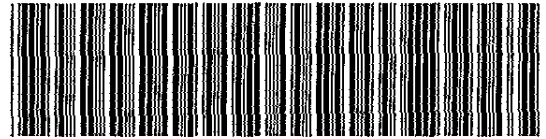



ARTICLES OF INCORPORATION
OF

UNIT #3 AT PAGE FIELD PLAZA COMMERCIAL
CONDOMINIUM ASSOCIATION, INC.
A Florida Corporation Not for Profit

The undersigned Incorporator, files these Articles for the purpose of forming a corporation not for profit under the laws of the State of Florida, and adopt the following Articles of Incorporation:

ARTICLE I – NAME AND ADDRESS

The name of this Corporation is UNIT #3 AT PAGE FIELD PLAZA COMMERCIAL CONDOMINIUM ASSOCIATION, INC. For convenience, the Corporation shall be referred to in this instrument as the “Association”, these Articles of Incorporation as the “Articles, and the By-Laws of the Association as the “By-Laws”.

The street address of the initial principal office of the Association is: 10 George Town, Fort Myers, Florida 33919.

ARTICLE II – TERM OF EXISTENCE

The Association shall have perpetual existence.

ARTICLE III – PURPOSE

This Association is organized for the purpose of providing an entity under the Florida Condominium Act (“the Act”) for the operation of a commercial condominium located in Lee County, Florida, known as “UNIT #3 AT PAGE FIELD PLAZA COMMERCIAL

CONDOMINIUM" (the "Condominium"), to be created under the Declaration of Condominium (the "Declaration").

ITEM IV – MEMBERS

The qualification of members and the manner of their admission shall be as regulated by the By-Laws.

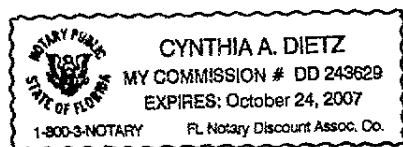
