# ARTICLES OF INCORPORATION OF VICTORY OUTREACH / ALCANCE VICTORIA – WEST MIAMI INC.

#### A RELIGIOUS NONPROFIT CORPORATION

## ARTICLE I - CORPORATE NAME

The name of this corporation shall be: Victory Outreach / Alcance Victoria - West Miami Inc.

ARTICLE II - PRINCIPAL REGISTERED OFFICE

Notwithstanding any other provision of these articles, the corporation shall not carry any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code (or corresponding section of any future federal tax code) or (b) by a corporation, contributions to which are deductible under Section 170 (c)(2) of the Internal Revenue Code (or corresponding section of any future Federal tax code).

#### **ARTICLE IX - DISSOLUTION**
