PLAN OF MERGER FOR ALHAMBRA COMMUNITY ASSOCIATION, INC.

THIS PLAN OF MERGER FOR ALHAMBRA COMMUNITY ASSOCIATION, INC. (this "**Plan of Merger**") is submitted in compliance with Section 617.1101 of the Florida Statutes and in accordance with the laws of any other applicable jurisdiction of incorporation.

1. Pursuant to this Plan of Merger, the Jupiter Isles Community Association, Inc. (the "**Jupiter Isles Community**") shall be merged into the Alhambra Community Association, Inc. (the "**Alhambra Community**").

2. The name and jurisdiction of the surviving corporation is:

3. The name and jurisdiction of each merging corporation is:

Jupiter Isles Community Association,, Inc.	Florida

4. The terms and conditions of the merger are as follows:

4.1. The Jupiter Isles Community shall be merged into the Alhambra Community and thereafter, pursuant to Section 617.1106, Florida Statutes, the separate existence of the Jupiter Isles Community shall cease.

4.2. Pursuant to Section 617.1106 of the Florida Statutes, the Jupiter Isles Community shall merge into the Alhambra Community and thereafter the Jupiter Isles Community shall cease to exist. The title to all real estate and other property, both tangible and intangible, owned by the Jupiter Isles Community shall vest in the Alhambra Community without reversion or impairment. The Alhambra Community shall be responsible and liable for all the liabilities and obligations of the Jupiter Isles Community. Any existing claims or pending claims against the Jupiter Isles Community shall be (1) continued as if the merger never occurred or (2) continued with the substitution of the Alhambra Community for the Jupiter Isles Community. Furthermore, neither the rights of creditors nor any liens on the property of the Jupiter Isles Community shall be impaired by the merger.

5. The Articles of Incorporation and By-Laws of the Alhambra Community shall continue in effect until amended in accordance with the provisions thereof.

6. Members of the Jupiter Isles Community are entitled only to the rights, if any, provided in the Articles of Merger.
