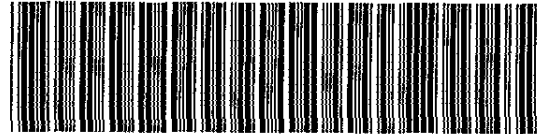

ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation is **PRESERVE OUR KEY BISCAYNE, INC.**

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is **325 Atlantic Road, Key Biscayne, FL 33149**

ARTICLE III: PURPOSE

The sole purpose of this non profit corporation is to preserve, protect and defend the quality of life of the community of Key Biscayne, Florida.

ARTICLE IV: QUALIFICATION
