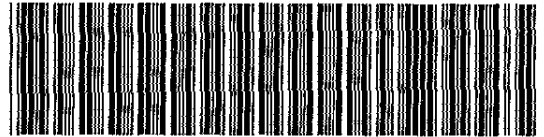

The undersigned, acting hereby as Incorporator for the purpose of becoming a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida, providing for the formation, liabilities, rights, privileges and immunities of a corporation, not for profit, pursuant to Chapter 617, Florida Statutes, and other applicable law, do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of this corporation shall be SILVER STAR CHILDREN'S CHARITIES, INC.

ARTICLE II

The street address of the principal place of business of this corporation is hereby designated to be 4960 Vogel Road, St. Augustine, FL, 32092, and the registered office of this corporation is hereby designated to be 4960 Vogel Road, St. Augustine, FL, 32092. The principal place of business and registered office may be changed in accordance with the By-Laws of the corporation or by appropriate action of the Board of Directors. The initial Registered Agent of this corporation whose business office is the same as the registered office is hereby designated to be SCOTT YEOMAN, 4960 Vogel Road, St. Augustine, FL, 32092.

ARTICLE III

The corporation is established to collect and distribute toys to the children of the community during Christmas time and such other activities as allowed by non-profit corporations under the Laws of Florida.

ARTICLE IV

The corporation may in its by-laws make any other provisions or requirements for the management or conduct of the business of the corporation, provided the same is not inconsistent with the provisions of this certificate, or contrary to the laws of this State or of the United States provisions or requirements for the management or conduct of the business of the corporation, provided the same is not inconsistent with the provisions of this certificate, or contrary to the laws of this State or of the United States.

ARTICLE V

This corporation shall have a perpetual existence unless sooner dissolved according to law.

This corporation shall have three (3) officers, President, Secretary and Treasurer.

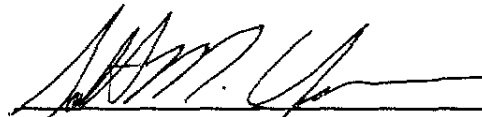
