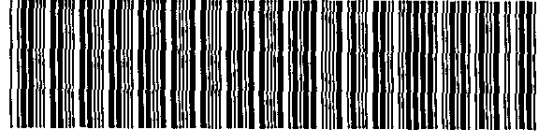

ARTICLES OF INCORPORATION

ARTICLE I

THE NAME OF THE CORPORATION SHALL BE: " THE ALL FAITHS
HUMAN AND CIVIL ASSISTANCE SOCIETY, INC.. ".....

ARTICLE II

THE PRINCIPLE PLACE OF BUSINESS AND MAILING ADDRESS OF THIS
CORPORATION SHALL BE :1741 west 11th street, Jacksonville,
Florida, 32209'..... 32209.

ARTICLE III

THE PURPOSE FOR WHICH THE CORPORATION IS ORGANIZED IS:

" ACQUIRE OR BUILD, EQUIP, MAINTAIN, OWN, AND PROVIDE FOR THE OP-
ERATION OF, OR OPERATE A HISTORICALLY BLACK RESEARCH LIBRARY, AND
A SCHOOL, OR SCHOOLS IN CONNECTION THEREWITH, WHILE EDUCATING THE
COMMUNITY AND PRISONS POPULATION AT LARGE WITH RESEARCHED INFORMA-
TION, AND EDUCATE, AND TRAIN BOTH EX-OFFENDERS AND THE COMMUNITY
AT LARGE IN HOW TO HELP AND ASSIST WITH BASIC HUMAN AND CIVIL
NEEDS, AND UPON SUCH TERMS AND CONDITIONS AS TO MEET, IF POSSIBLE
THE ESPENSE THEREOF, BUT WITHOUT MAKING PROFIT THEREFROM.

THE MANNER IN WHICH THE DIRECTORS ARE ELECTED OR APPOINTED:....

AS THE DIRECTORS APPOINT MORE. NO MEMBERS SHALL VOTE ON ANY
DIRECTORS APPOINTED.

ARTICLE VII

THE INITIAL MEMBERSHIPS:

THIS WILL BE A TWO CLASS MEMBERSHIP ORGANIZATION WITH A ELITE MEMBERSHIP AND GENERAL MEMBERSHIP AS THE SECOND CLASS OF MEMBERSHIP THAT SUPPORT THE BOARD OF DIRECTORS AIMS AND DIRECTIONS FOR THE ESTABLISHMENT OF THE LIBRARIES, VARIOUS DEPARTMENTS AND SUPPORTING PROGRAMS.

THE DIFERENCE IN MEMBERSHIP ARE SPELLED OUT IN THE DIRECTORS ISSUED RESOLUTIONS AND ONLY AVAILABLE TO REGISTERED MEMBERS UNLESS YOU ARE A REGISTED FELON, AND INCARCERATED, THEN THEY WILL NOT BE AVAILABLE SINCE THERE ARE RESTRICTIONS ON THEIR MEMBERSHIP AND PARTICIPATION. HOWEVER, THE COMMUNITY ADVISORY BOARDS WILL ESTABLISH PRISONS GUILDLINES.

ARTICLES OF INCORPORATION

ARTICLE VIII

THE CORPORATION AND DIRECTIONSHIP SHALL HAVE PREPETUAL EXISTENCE AND DIRECTORSHIP OF THE ORGRANIZATION, AND OF ANY OTHER CHARTERED , OR ASSOCIATED LIBRARIES THAT IS FOUNDED ON THE PRINCIPLES OF THE ARTICLES OF INCORPORATION, THE RESOLUTIONS, AND BYLAWS FOR MEMBERSHIP. THE DIRECTORS MAY APPROVE:

IN SOME OF THE SMALLER CITIES, AND TOWNS WHICH ARE ASSOCIATED WITH JACKSONVILLE, THE COMMUNITY ADVISORY BOARD MEMBERSHIP OF THE ELITE MEMBERS MAY ACT, MANAGE, OR OTHERWISE DIRECT THE ORGANIZATION AFFAIRS AS DIRECTORS WHILE ADVISING THE JACKSONVILLE, LIBRARY DIRECTOR OF STATEWIDE AFFAIRS.

ARTICLE IX

THE AFFAIRS OF THE CORPORATION ARE TO MANAGED BY THE DIRECTORS OR THEIR APPOINTED ASSISTANTS OF THE ELITE MEMBERSHIP AS STAFF PEOPLES, AND SHALL SERVE A TERM OF NOT LESS THAN ONE YEAR, NOR MORE THAN THREE YEARS WITHOUT REAFFIRMATION OF THEIR STAFF POSITIONS BY THE DIRECTORS MAJORITY VOTE.

ALSO, ANY PROVISION, NOT INCONSISTENT WITH THIS ACT OR WITH ANY OTHER LAW, WHICH LIMITS IN ANY MANNER THE CORPORATE POWERS AUTHORIZED UNDER THIS ACT.

ARTICLE X

THE INITIAL BYLAWS OF THE CORPORATION ARE TO BE MADE, ALTERED OR AMENDED BY THE DIRECTORS, WHILE SHOWING THE RELIGIOUS, CHARITABLE SCIENTIFIC, AND EDUCATIONAL PURPOSES.

THE ELITE MEMBERSHIP MAY SUBMIT RECOMMENDATIONS ON SOME OF THE ADDITIONAL BYLAWS SUBMITTED TO THE BOARD AFTER EACH CHAPTER 90 DAYS ORGANIZATION COMMITTEES MEETINGS.

ARTICLE XI

ANY AND ALL AMENDMENTS TO THE ARTICLES OF INCORPORATION ARE TO BE MADE BY THE DIRECTORS, WHO MAY ACCEPT, OR REJECT MEMBERS IN GOOD STANDING RECOMMENDATIONS PROPOSED BY THEM WITH 2/3 MAJORITY OF THE PRESENT VOTING MEMBERS PROVIDING 30 DAYS NOTICE TO THE DIRECTORS.

ARTICLE XII

ALL LEGAL INSTRUMENTS OF THE CORPORATION SHALL BE SIGNED BY A DIRECTOR UPON RECEIPT SUCH FROM THE REGISTERED AGENT WHICH MAY BE SEAL WITH THE CORPORATION SEAL, AND ATTESTED BY SAID DIRECTOR-SECRETARY, OR IN SUCH MANNER AS MAY BE AUTHORIZED BY LAW.

THE DIRECTORS SHALL MAKE REPORTS OF THEIR RECEIPTS, DISBURSEMENTS , WHILE BALANCES THE AFFAIRS OF THE CORPORATION FOR THE ANNUAL SESSIONS OF THE MEMBERSHIP SESSIONS AND WHEN SO LAWFULLY REQUESTED SHALL MAKE MONTHLY REPORTS TO THE SPECIAL CLASS OF MEMBERS ENTITLE THE ELITE.

ARTICLE XV

ANY PROVISION NOT INCONSISTENT WITH LAW, REGARDING THE REGULATION OF THE INTERNAL AFFAIRS OF THE CORPORATION, INCLUDING WITHOUT LIMITATION, ANY PROVISION WITH RESPECT TO THE RELATIVE RIGHTS OR INTERESTS OF THE MEMBERS AS AMONG THEMSELVES OR IN THE PROPERTY OF THE CORPORATION ARE TO BE DECIDED AMONG THE CURRENT DIRECTORS.

MEMBERSHIPS

THE MANNER OF TERMINATION OF MEMBERSHIP IN THE CORPORATION SHALL BE SPELLED OUT IN THE BY LAWS.

THE RIGHTS, UPON TERMINATION OF MEMBERSHIP OF THE CORPORATION THE TERMINATED MEMBERS, AND THE REMAINING MEMBERS.

THE TRANSFERABILITY OR NON TRANSFERABILITY OF MEMBERSHIP.

ARTICLE XVI

THE DIRECTORS SHALL CONTROL THE DISTRIBUTION OF ASSETS UPON DISSOLUTION OF THE FINAL LIQUIDATION OF ANY OF THE CORPORATION ASSETS WHILE MANAGING ANY OUTSTANDING DEBTS INCLUDING ANY TAXES THAT MAYBE OWED WITH JUST COMPENSATION.
