

Articles of Incorporation

A Non Profit Organization Of ADEJAX, INC. Pursuant to Chapter 617.0202, F.S.



Article I

The name of the corporation is:

ADEJAX, INC.

Article II

The principal place of business and mailing address of the corporation is:

Article III

The specific purposes of which the corporation is organized:

Said corporation is organized exclusively for the following purposes:

- 1. With educational and cultural purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
- 2. To assist the members of the Ecuadorian community in Duval, Nassau, St. Johns, Clay, Putnam and Flagler counties in the State of Florida to comply with the Federal and State Laws.
- 3. To promote the Ecuadorian culture and customs to the general population residing at the counties mentioned above.

Article VIII

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing and distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
