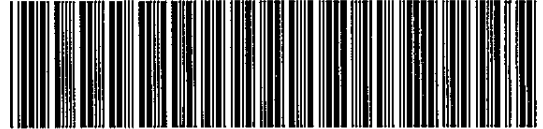

The undersigned, for the purpose of forming a not for profit corporation pursuant to the laws of the State of Florida, hereby makes, subscribes, acknowledges and files the following Articles of Incorporation:

ARTICLE I

The name of the Corporation shall be:

TONY VALDES INTERNATIONAL MINISTRIES INC

ARTICLE II

The principal place of business and address of the corporation shall be 915 NW 197th Terrace Pembroke Pines, Fl 33029

ARTICLE III

This corporation is organized as a not for profit organization to spread the gospel of Jesus Christ, to establish structured support services of Evangelism, economic development and other ministries of Jesus Christ and the creation of religious programs. These programs shall not be limited to health, homeless and child care, Christian education, job training, counseling, employment and other aid programs, regardless of race, color, creed or national origin.

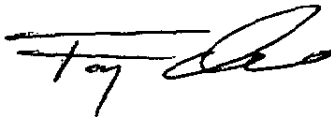

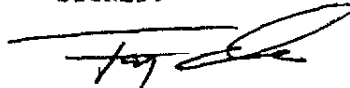
