Pursuant to Chapter 617.0202, F.S., the Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of Florida, do hereby certify:

First: The name of the Corporation shall be Alliance of Judeo Apostolic Churches Incorporated. This corporation shall have initially, two auxiliary churches namely Heaven Bound Pentecostal Church and Metro Harvest Church.

Third: Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501©(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
